INTRODUCTION

Nowadays, people get information easily through mass media. "Mass media of communication is communications that use medium or tool which can reach a lot of mass and a wide territory". "Mass media communication will not separate by the mass, because in mass media communication, the delivery of the message is through the media". (McQuail, 2005, p. 3). Mass media is a tool that is used to reach mass audience. It has a very big role as a disseminator of information. Besides, it is also a tool for conveying news, researches, opinions, or general ideas of things. Therefore, it can form a public opinionin society.

News has a lot of categories, one of which is criminal news. "Criminal news has always been the main attraction for the public" Kate Bates said. Terrorism is not a new thing, terrorism is a coordinated attack with the aim of causing feelings of terror towards a group of people. Different with war, acts of terrorism are not subject to the procedures of warfare, such as sudden execution time and random target. The act of terror causes a loss of secure feeling in society, it also sent down the government authority as a body that is supposed to provide protection and security in society (Sukawarsini Djelantik, 2010: 1)

Acts of terror ensued in Indonesia too, it can be seen from the Bali I bombing case on 2002 in whichthere were 202 casualties and 209 people injured. The bomb case happened again for the second time in Bali, namely the JW Marriot hotel. Next bombing happened in the Ritz Charlton hotel, then the Australian Embassy and Sarinah area. The last cases of bombing happened in Surabaya on May 2018. The news is being hot news, because this is unsual criminal acts. The perpetrators of this bombing is a Muslim family who committed suicide bombing in the church just as people are worshiping. Lately, the news about the problem of differences religion in Indonesia is so very sensitive. After the Bali bombing in 2002, it affects of people who worry about terrorist. Because of that, the government build Densus 88 to make people feel safe.

There are many news in various print and online media about the case and they can make researcher know what The Jakarta Post newspaper does in framing problem about the case of church bombing in Surabaya. First results of research Erick Meiraldi (Faculty of Communication Sciences Jayabaya University, 2002). His analysis of framing of criminal news isabout pick pocketing in newspaper Lampu Hijau Edition March 2009, with framing analysis method he concluded that the authors choose framing pan and kosicki analysis model. Because this model when compared with other framing models, more can be seen fromthe construction of the meaning of events associated with

the object of research. Lampu Hijau has separate frame to the news in this case Lampu Hijau newspapers construct criminal news pickpockets built with two variables. Factor is divided into two variables that are variable in media and variable outside media. Lampu Hijau reporters restructure criminal news pickup tends to support for eradication of acts criminal pickpocketing. The news warnspeople to be aware of criminal acts of pick pocketing.

Second Analysis Of Framing on Sarinah Bomb in Kompas.com and merdeka.com by Kumala Citra SomaraSinaga from Journalism Faculty of Social Political Sience Riau University, Pekanbaru. This research isusing qualitative method, with analysis of framing fromZhongdang Pan and Koscki Models. The objects of this research are the news that isrelated with the case of "Bom Sarinah" in Kompas.com and merdeka.com which wastaken by cascading everyday, based by different topics from 14 January 2016 - 18 January 2016. Conclusion was made from the results of framing analysis regarding the news of the Sarinah bombing case at Kompas.com and online media merdeka.com reconstruction of journalists in both media, namely online media; Kompas.com and merdeka.com. Reconstruction results or framing analysisseesthat theattitude Kompas.com in this event more accentuates the human interest side of the police, seen from how Kompas.com raised positive image of the police in handling the Sarinah bombing case (news on the 16th January 2016) and resource persons also used Kompas.com only from one resource person, namely the police (news 14-17 January 2016). Kompas.com with the motto of "celebrate this difference", preach the Sarinah bomb case from the point of view ofwhat is happening in the field with use two news sources

(news January 17 and 18 2016). Meanwhile, merdeka.com is notan independent mediawith display news that is not bound by certain understandings orcertain interests, which can be seen from each merdeka.com news that is not "heavy" certain parties (news January 14-18 2016), the point of view taken from the news is the incident at field using some news sources, such as sourcesfrom surrounding community and the head of the BNPT (news 15, 18 January 2016).

METHOD

The researcher uses qualitative method approach to gather information focuses on describing a phenomenon in a deep comprehensive manner. This articles are analyzed using qualitative method. According to Sukmadinata (2005) the basis of qualitative
